
# fl D fl R E P O R T by Amber Lawson

# Executive Committee Report

#### August 28, 2018

- •Call to Order: President Ash Walker called the meeting of the CDDS Executive Committee to order at 7:00 p.m. August 28, 2018. Dr. Ash Walker gave the Invocation.
- •Roll Call: A quorum was present. Those present were: Drs. Amber Lawson, Samer Othman, Don Benton, Lindsay Holliday, Bill Argo, Paul Fraysure, Michael Wright, Nancy O'Brien, Amy Lee, Noel Craig, Deana Holliman-Smith, Pinkney Gilchrist, Ash Walker.
- •CDDS Bylaws Update: Discussion on revisions of current CDDS Bylaws discussed. Last update was in 2007. Members present asked for Scott DeFranco to look at our current bylaws and give suggestions for an update to be brought back to the next CDDS meeting to review before sending out a copy of the updated bylaws to the district for complete review before voting on update.
- •Discussion of Services to be provided to the CDDS from the GDA: Services were discussed in detail on what the GDA can provide to the CDDS. The newsletter is costing about 2500 per year. The committee requested that Frank with the GDA quote CDDS for price to create and mail the CDDS newsletter on a quarterly basis. The committee also requested to have a mockup of current newsletter the GDA produces for the Northern District. Additionally, the committee requested cost estimates to manage the non-profit status of the CDDS. A list of services includes the following: 1. Accounting, financial management, budgeting, tax audits, District financials to be set up in Quick Books. 2. Routine legal assistance management of nonprofit status and annual filings with the IRS and annual 990 filings for the CDDS entity. 3. Meeting coordination management for CDDS setting up meeting space, meeting calendar, and attendee communications. 4. Arrange district legislative Annual meeting for CDDS. 5. CE program speakers for quarterly CDDS meetings. 6. Website formation and updates on monthly basis. 7. Membership dues and retention for CDDS. 8. Maintain Email List on a guarterly basis.
- •Update on non-profit for CDDS and Articles of Organization: Currently, an attorney, David Pope has been retained to create all necessary documents for compliance for the CDDS. Articles of Organization documents have been completed and registration with the Secretary of State has been completed.
- Discussion on CDDS GDA Officer Meeting: The GDA President Bradberry and staff will brief members of the CDDS on the important issues regarding dentistry in Georgia. Membership services and legislative updates will be given at the meeting.

- •CDDS Newsletter: Discussion regarding the format of the CDDS newsletter recommended that in future issues the BOT district action takeaways be placed as an addendum to make the newsletter flow better.
- •Incorrect email and addresses for CDDS members: Lindsay Holliday brought forward 8 members from the CDDS with wrong emails. Corrected emails and addresses will be updated.
- •CDDS checking and money market account: Don Benton is moving the CDDS checking account from Suntrust Bank to Affinity Bank.
- •Future meetings: •Nov 18, 2018 Idle Hour Country Club in Macon. UBS Financial Services will present "Financial Strategies for Dentists" to navigate the new income tax laws. •December 4, 2018, Annual Legislative meeting at Brickyard Golf Club in Macon Ga. Bill Argo discussed the specifics of the meeting. He will be training a new legislative affairs person in the next year as he transitions out of this role. •Samer Othman will be setting up speakers for the 2019 year for the CDDS.
- •2019 OSHA/HIPPA review course: For the past 3 years, Patterson Dental Company has sponsored Linda Harvey for annual HIPPA/OSHA course. Some CDDS members have asked for a different speaker to get a new perspective. Ms. Carol Page, RDH. has just developed a new HIPPA/OSHA course aimed at also team building. Members of exec requested to ask local rep from Henry Schein Dental Company to sponsor Carol Page for the next year's course. Dr Samer Othman will follow up on this event.
- •Integrity Buyers Group: Mike Loden stressed the importance of using the GDA Integrity Buyers Group for obtaining some or all dental supplies. The membership fees have been waved and many new products are now available.
