

- Tommy opened the meeting with a prayer.
- Bill Argo announced that he will be hosting a fundraiser for Lt. Gov. candidate David Shafer at his home on June 14 to meet the candidate.
- Arrive after work and spend a few minutes with friends discussing his campaign. Scott Lofranco and Bill will coordinate with an invite and suggested donation for the casual event.

- Next, the EC reviewed the calendar for the upcoming year. Ash is working on the calendar to have the GDA Officer Visit in Sept.
- Bill Argo is working to have a legislative reception date finalized very soon as well.
- Ash asked for suggestions for the Nov.15 2018 Mtg speaker. The EC tossed around some topics that we may have the option of DCG faculty speak to us or use a speaker from an outside source.
- The assembled group noted that GMOM is August 10 and 11 in Augusta and there is a need for both funds and volunteers for this large event. Tommy and Ash encouraged all to participate if at all possible and spread the word.
- Under new business: Tommy mentioned the possibility of getting Carol Paige to give the OSHA/Hippa review next year. Lindsay requested that we continue updating our district database of e-mails at this meeting. He noted that we are far from complete and accurate membership data and the GDA is nowhere close to having good data in a form that is usable for the districts.

Virtual Credit Card Reimbursements: During the 2018 legislative session, the GDA proposed legislation regulating virtual credit card reimbursements by insurance companies. The bill prohibits insurance plans from mandating that healthcare providers and hospitals only accept virtual credit card reimbursement payments and their corresponding fees. As a result of the hard work of the bill's sponsor, State Rep. Lee Hawkins (R-Gainesville), along with Georgia Dental Association members and staff, HB 818 goes into effect **January 1, 2019** and stands to save every dentist hundreds of thousands of dollars over the course of their practicing years.

2019 Leadership GDA Program: Applications for the 2019 GDA Leadership Program are due **February 1, 2019**. Leadership GDA helps members grow into more knowledgeable and confident leaders within the dental community. Participants also gain a better understanding of GDA and how to become involved in leadership in organized dentistry. The program includes a kick-off/GDA 101 session, two webinars, a self-study, an in-person workshop, and spokesperson training. Program participants also choose two electives from a list including LAW Days, the GDA Convention, and BOT/HOD meetings.
