EC Meeting November 8,2011;Office of Amber Lawson

- Alfred Peters opened the meeting and thanked all for their participation. Pres. Alfred then asked for approval of the minutes in the newsletter, motion made and approved.
- Treasury Report approved as written in Newsletter
- Awards: Deena Holliman-Smith reviewed awards and noted that Alfred Peters had been approved for the Honorable Fellow Award.
- **Dental Health:** Shirley Fisher asked for documentation of activities in our offices and schools during February. She noted the conflict with the CDDS meeting as it is planned for the first Thursday and Friday, and historically some coordinated event has been planned on that first weekend-most likely will not happen this time.
- Legislative: Amber Lawson has sent out invitations to legislators and the dentists. It is scheduled for Nov. 29, 7pm at the Brickyard. She asked for a vote for convenience and uniformity to add beer and wine to our bill for this function that would add approximately \$900 to the tab and eliminate having to get tickets for beer and wine. Motion made, seconded, discussed and passed.

CDDS LAW Day is February 15 this year and we need maximum participation; speak with your colleagues to foster another successful day in this important relationship building activity.

- GADPAC: Paul Fraysure noted that PAC funds have never been so important! Please give generously at renewal time.
- Emile T Fisher Dental Education Foundation: Paul Fraysure noted that funds have fallen off in the last Two or Three years due to a sagging economy and the number of scholarships has had to be decreased.
- BOT: See summary report
- ADA Delegation: Jay and Kara See report.
- Hygiene Programs: Shelia Shah is ready to present scholarships at the membership meeting Thurs. evening. A question was raised regarding the recipients bringing a guest to the meeting. After some discussion motion was made seconded and passed that only the actual recipient and the respective program director or their designee may be in attendance at the presentation.
- New Dentists: Ched Smaha reinforced the continuation of the New Dentist reception as a mechanism to cultivate leadership and fellowship. There were about 15 people in attendance at the Fish 'n Pig On October 20. Katy Garvin will help decide future events and mechanisms to offset

#### Committee reports

- Governmental Affairs: Dr. Jim Hutson requested that each district identify appropriate individuals to attend the ADA Washington Leadership Conference May 7-9, 2012.
- Task Force to Implement Mission of Mercy Project: Wrap-up of the 2011 GMOM event held August 12-13. A total of 2,179 patients were checked in and care was valued at \$1.7 million. Almost \$163,000 in in-kind donations were given. On October 7, the official GMOM 2011 video was posted to the web site. DVD copies were distributed to all Georgia legislators, Governor Deal, Lt. Governor Cagle, Commissioners of the Departments of Community Health, Public Health and Human Resources.
- Task Force to Study Future GMOM Project: Committee is investigating two facilities in Gwinnett County for a June 2013 event. [11-11.12] The BOT postpone the request to contract with the Gwinnett Center for a June 2013 GMOM event until the January Board of Trustees meeting.
- Leadership GDA: Dr. Vernon highlighted the Leadership GDA proposal and encouraged districts to send in nominations for the first class as soon as possible with a December 1 deadline approaching. Applications can be obtained from Nelda Greene at the GDA office.

# Highlights from the Board of Trustees

November 5, 2011

Central District Members Present: Jim Hall, Jay Harrington, Mike Loden, Michael Wright. Visitors: Ty Ivey

- Council on Dental Health is reviewing the issue concerning the standard of care for placement of sealants and the appropriate level of GDA involvement in this issue. The Council will report at the January 2012 BOT meeting.
- Promotion of the GHSU student Mentor Program is in progress. Dentists are encouraged to enroll in the program.
- Dr. Vernon reported on the 2012 GDA Position Papers. No comments were submitted for changes.
- Botox and derma fillers policy discussion: The BOT discussed a proposed policy on Dentists' Use of Botox, Derma Fillers and other Topical and Nontopical Treatments. [11-11.05]
- Patient Protection Task Force Dr. Ty Ivey provided an update on the activities of the PPTF. He stated that the committee identified its top three priorities for implementation of the recommendations from the GDA White Paper; member education ranked number one. Of great concern to the task force is that there are no data to support the work force principles concerning shortage areas and dentist to patient population numbers. Therefore, the PPTF believes that it is critical to obtain correct and reliable data. Ms. Phillips presented a proposal from the Georgia Health Policy Center to conduct a workforce survey mapping all of Georgia's dentists, including satellite offices, auxiliary personnel and other key data obtained in Dental Health Professional Shortage Area surveys. The BOT discussed various avenues for securing funding which include the ADA State Public Affairs Program, dental public health and foundations or other organizations that would be interested in this data. [11-11.07] Dr. Sidney Tourial moved for the GDA to move forward with the dental workforce survey pursuing all possible resources for additional funding and for the BOT to recommend to the Finance Committee an expenditure of up to \$100,000 by utilizing the public relations critical issues fund and excess revenues and, if needed, utilizing the GDA reserve fund. The motion passed unanimously.
- Executive Director's report Ms. Martha Phillips reported on the following: 2012 Legislative Issues: budget; Medicaid; silent PPO legislation; physician and dentist autonomy bill;
  - Other trends: FTC proposing creation of a 'super board,' which would regulate all professional boards rather than profession specific boards; Massachusetts law requiring participation in networks as a stipulation for licensure (these are the state sponsored plans similar to the plans that will be formed under the health care reform law).
