

would not be so many resumes being presented by employees who had been the victims of dental downsizing.

Here is the real bridge. Most of the Foundations in the country who have an interest in health (Pew, Kellogg, Robert Wood Johnson, etc) have declared that there is a serious problem in our country relating to dentistry and that is Access to Care. The logical mantra to develop that train of thought is that Access to Care is caused by a SHORTAGE OF DENTISTS.

Who do you think came up with the statistics that allow all of these people to make these claims?

This is the real kicker. There are no accurate statistics. Let me repeat that. There are no statistics that are valid that can make the case either way. And yet, the move is afoot to increase the number of dental schools in the US by 20 by 2020. The dental academy in Georgia (AKA the GHSU College of Dental Medicine) is expanding its class size from 62 to 80 for the Fall of 2012 with a goal of 100, possibly by 2016. (You do the math - that is an increase of 61%.) And, by the way, all of the foundations and the Public Health Guru's are still rushing helter skelter to develop high school graduates with two years of training who will be empowered (you might say licensed) to do most of the procedures that general dentists do today.

Now is the time to tell you once again that you should be proud of YOUR GEORGIA DENTAL ASSOCIATION. We are in the process of taking a comprehensive, independent survey of the dentists in Georgia to determine whether we have a shortage or not. Many of us who have worked with this issue are confident that the statistics will reveal that at worse we have a POSSIBLE maldistribution of dentists and not a shortage. If there is no shortage, then those who would give away our scope of practice to high school graduates will have a problem claiming that there is a shortage and a resultant Access to Care crisis for these high school graduates to solve.

NOW WE COME TO WHAT YOU CAN DO? DON'T DELAY IN FILLING OUT THE SURVEY. THIS INFORMATION IS CRITICAL. TELL YOUR FRIENDS ABOUT IT. THE MORE DENTISTS IN GEORGIA WHO RESPOND TO THE ONLINE SURVEY, THE LESS MONEY WE WILL HAVE TO PAY TO HAVE THE RESEARCH COMPANY CALL EVERYONE TO COMPLETE THE SURVEY.

•GADPAC - Paul Fraysure-- - No recent discussions.

• Nominating Committee - Kara Moore - See slate elected on Feb 2nd.

•MOM - Mike Loden - June 13-16, 2013, please identify dentists in the CDDS that might provide expertise, care or training in Nursing Homes, Celeste Coggin can give us a coding seminar next year at no charge to the CDDS, Expanded Dental Assistant courses for Pedo will cost about \$500--

•Workforce Committee - Kara Moore discussed the upcoming Provider Census/Survey for Workforce Committee to develop independent data. ADA is giving the GDA \$100K to perform the survey. There is a small ADA dues increase this year. Update on Mid-Level providers. 18 new dental schools will be opening in the next 4-5 years; this will produce 1,500 extra dentists per year.

•Dental Hygiene: - Paul Fraysure reports hygiene schools are getting ready for mock boards and national bos\ards. Mid Ga Tech is discussing building a new Allied Health Building that might include Dental Hygiene... they need more room. Applicants now need over 40 hours of shadowing. Central Ga Tech may be opening an Assisting Program.

•New Members: Kendrick Matthews for Katie reports Dr Duval (ortho) and 2 more new dentists applications for CDDS are in.

•Governmental Affairs: Don Spillers reported on a new federal tax law. Sunshine Law states all dental suppliers must report any purchase over \$10-- this includes any free dinner or classes. Reports will go online for the public to review.

•GDA Leadership Program: New CDDS dentist Jason Mann is participating in the new GDA Leadership program

Georgia Declared Dental Shortage Area!

Every speaker taking part in the dedication of the new GHSU (That's Georgia Health Sciences University if you have been on Mars) College of Dental Medicine (also a change) last year in Augusta declared that the mission of the school was to eliminate the problems created by the shortage of dentists in Georgia. The Merriam-Webster Dictionary defines a shortage as a deficiency in the amount required; Deficit.

Before I tell you where we are going with this, please let me remind you that for the last two years almost everything that I have written has had some thread of "Access to Care" in it. Now back to the point. If we have a shortage of dentists in our state, please tell me why so many people are complaining about not being busy. Why are we continuing to have dentists declare bankruptcy? Is there a deficit of dentist in Georgia? If there were, it would appear that everyone you know would be working long hours and there

- •GDA President's Report: 2013 G MOM event: Dr. Vernon asked Dr. Jonathan Dubin to update the BOT on the proposals for the 2013 GMOM event. Dr. Dubin stated that the Gwinnett Center had made several concessions concerning food and were only requesting payment for direct services, such as security, cleanup, and event supervisors. [12-1.01] Dr. Jonathan Dubin moved for the GDA to recommend that the GDA Foundation for Oral Health contract with the Gwinnett Center at a cost not to exceed \$25,000 for a June 13-16, 2013 Georgia Mission of Mercy event. The motion passed unanimously
- •Ms. Phillips stated that the GDA is also working with Senator Goggans on the introduction of a Volunteer Health Care Services bill that would allow out-of-state licensed dentists to obtain a temporary license to provide probono services at certain charitable events, such as GMOM.
- •ADA Councils and Commissions: Dr. Celeste Coggin, Council on Dental Benefit Programs, referenced her written report. She stated that she is giving the Code Workshop for the Northern District in February. If dentists are interested in attending the Code Workshop, they should contact Hank Holderfield at the Northern District office. Dr. Coggin told the District representatives that she is available to present the Code Workshop to other districts at no charge.
- •Membership Services: Dr. Becky Weinman made a request concerning providing an Expanded Duties Course VI (for pediatric assistants). [12-1.05] Dr. Sidney Tourial moved for the GDA to approve the request from the Membership Services Committee Chair for Dr. Becky Weinman to offer at least one Course VI Expanded Duties session at her private office for pediatric assistants and for the GDA to approve instructor and instructor assistant fees of \$510.00 The motion passed unanimously.
- Patient Protection Task Force: Dr. Ty lvey provided information about the need for a dental workforce census and the ways in which the Patient Protection Task Force could utilize this information to enact recommendations from the GDA's White Paper on access to dental care. After much discussion, the BOT reaffirmed its original recommendation to support this study monetarily.
- •The following nominations were submitted to the House of Delegates for approval for a three-year term as trustees on the GDA Board of Trustees effective July 22, 2012: Dr. Mike Loden, Central District (term expires 7/15)

ADA REPORT Kara G MOOR

While having a conversation with one of my local colleagues, it was brought to my attention that I take for granted two things. 1) People actually read the newsletter cover to cover soaking in every word, and 2) People understand all of the issues that I, as an ADA delegate, feel so strongly about. So, I have decided to format this ADA report into a guicker, easier to read format that will highlight the ADA's current activities using BULLET POINTS! Who doesn't love bullet points? Quick, visible and straight to the point so here goes....

What has the ADA been up to?

- •The ADA is involved in heavy lobbying efforts to repeal the medical device tax which can cost every dental practice approximately \$3000/year.
- •We are assisting a dentist/legislator (Rep. Gozar, AZ) in his quest to the pass the dental insurance fairness act. What's that you ask??? \$Passing the fairness act will force all insurances to comply with an assignment of benefits law. Ensuring that dentists that are not 'in network' can still have payments sent directly to them. \$It will also provide a uniform co-ordination of benefits which will allow individuals with double coverage to actually receive a 100% of the benefits they are paying for and not get caught in a situation of a non-duplicating clause.
- •The ADA is assisting the GDA with their goal to obtain an accurate census of the dentists of Georgia by financially supporting them in their efforts. Have you completed your census?
