

# The Ty Report ... "Only in Alaska ?..."

Most of you will recall my story on the first time I heard the words, Mid Level Provider. It was September 2003 and I was at a meeting of the ADA Council on Government Affairs. I was shocked. The label at that time was the Alaska Dental Health Aide Therapist (ADHT). The then director of the ADA's Washington Office and chief lobbyist of the ADA, Ms Dorothy Moss, assured the members of the Council that the DHATs would be contained "ONLY IN ALASKA." I told her and the Council that was not possible and the Council forwarded a resolution to the ADA House of Delegates that formed the ADA Task Force to study the ADHT. I was fortunate ( or maybe unfortunate ) enough to be appointed to the task force by Dr. Gene Sekiguchi, President of the ADA.

Since that time a lot has happened. The Foundations of this country (Kellogg, Pew, Rasmussen, Robert Wood Johnson, etc) have waged a campaign to change the social order of the practice of dentistry by promoting the creation of Mid Level Providers, and to them, "ONLY IN ALASKA" means nothing. In Georgia you will remember that we produced two years ago a white paper in defense of the practice of dentistry and in defense of the educational model. Many probably thought that because of Georgia's activism on this issue, it would be a long time before we had face the music and that the main battles on this issue would be fought somewhere else.

Well, on July 16, 2012, all of that changed. On the 16th and 17th of July at the J.W. Marriott in Atlanta, a meeting was convened by the Morehouse University School Medicine and hosted By Dr. Henrie Treadwell of that institution. The Georgia Dental Association was allowed to have a delegation at the meeting that included your author and eight other officers and members of the state association. Oh, by the way, also included were a cast of Who's Who in the world of Mid Level Provider advocates in the United States. Try these names - Dr. Louis Sullivan, Dr. David Satcher, Dr. David Nash, Dr. Ron Nagle, Dr Frank Catalanotto, Dr. Caswell Evans and a guy from a subsidiary of the Kellogg Foundation Mr. David Jordan. If you never heard of these guys, you might want to Google them up for a little light evening entertainment. These people all have a purpose and it is to establish a school for dental Mid Level Providers at the Morehouse School of Medicine. (Please don't believe that the last sentence was a misprint.) If you think that I am joking, I am not. They are dead serious and they plan to do it with money from the Kellogg Foundation (you know the company that sells sugar loaded "healthy" breakfast foods to the children of America)
