

### Highlights from the Board of Trustees

#### President's Report

Dr. Tourial reported on the following topics:

• Council on ADA Sessions; GMOM;

•GDA member survey – Dr. Tourial referenced the recently completed member survey and Nelda Greene explained the methodology, response rate and highlights of the results;

•Meeting with Georgia Dental Hygienists' Association (GDHA) – Dr. Tourial provided a timeline beginning April 2012 that involved discussion on the topics related to dental hygiene issues with the Patient Protection Task Force and the president's advisory committee.

Dr. Jim Hall moved for the GDA to correspond with the Hinman Dental Society thanking them for continuing to require membership in the GDA and for continuing to verify membership each year. The motion passed unanimously.

#### Report of the Executive Director

Ms. Martha Phillips reported on the following topics:

•Patient demand for dental services study. Dr. Byron Colley moved for the BOT to refer the demand study proposal to the Patient Protection Task Force for its review and comments and for the GDA to pursue ADA SPA funding for this study. The motion passed unanimously.

•Medicaid - Ms. Phillips provided highlights from the latest DCH external quality review audit which shows that the CMO's rate of children being seen by a dentist in Georgia is above the national average. However, since this is based on the somewhat flawed HEDIS score, it is not a true picture of actual dental care.

•Board of Dentistry – will be operational at the Department of Community Health by July 1.

#### Membership Services

Dr. Becky Weinman reported on the activities of the Dental Recovery Network, Expanded Duties courses, Wastewater/BMPs, and contract analysis performed by the GDA.

#### Finance Committee

Dr. Jay Phillips presented the 2013-2014 GDA budget for the BOT's review. [13-6.07] Dr. Jim Hall moved for the BOT to approve the 2013-2014 GDA budget as presented. The motion passed unanimously an executive director were apparent, but during all of this, the political statue of the GDA began to grow.

Under the Gold Dome in Atlanta, she became a familiar face. She grew to become one of the most trusted and effective lobbyist in the state and when Charlie Norwood went to Congress, she became a national player as well. All of this happened while the GDA core office became more and more active in providing member services.

On Wednesday, July 31, Martha Phillips retired as Executive Director of the GDA. Everyone in the Georgia Dental Association is in debt to her whether they know it or not. But for the next 30-40 years, everyone man, woman, and child who relates to the profession of Dentistry in this state, will remember this dynamic and unequalled person who was kind enough to come our way and make our lives better. Martha Phillips was the most dynamic human being with whom I have ever had the privilege to work. She is my friend and I will miss her.

### The Ty Report



#### "A Tribute to a Comrade"

In 1978, Lindsay Holliday's dad, Pete, was the incoming President of the Georgia Dental Association. I had been the Secretary/Treasurer of GADPAC under Loy Strawn and Loy was resigning from the chairmanship of the PAC. Pete asked me assume the chairmanship of GADPAC. We were a fledgling organization as were most Political Action Committees at that time. We operated out of a box out of my house. The Georgia Dental Association had just moved from its office in Macon where it had been for years. Atlanta was taking over Georgia and the GDA was going big time and moving to the Big A. Steve Janus was the Executive Director in this new office and his secretary was Martha Phillips.

As GADPAC Chair I had lots of dealings with the GDA office so I got to know the "secretary" pretty well. She was fun to talk to and she was as best as I could tell a really good "secretary." Then in 1986 I turned the PAC over to Nelson Conger and turned my attentions toward ADPAC and after one year I was placed on the ADPAC Board when the 5th District split into the 5th and the 17th ADA districts. Also, Don Johnson one of my main mentors was being installed as GDA president. Somewhere in the months before he assumed the presidency, Don Johnson discussed a new vision for the GDA with the Executive Director and as a result of these conversations, the Executive Director decided to retire. Don Johnson hired, with a hand shake deal, Martha Phillips the secretary to become the new Executive Director.

Soon after she took the helm, her interest in the lobbying activities of the Association became very obvious. I remember remarking to her some where in those early days that I never knew that she had such much interest in the political arena. The office that she was hired into had two employees. As it grew in the Kroger center it had three employees. We soon outgrew the Kroger center and moved to another location which had a nice glass overlook. That didn't last long as the headquarters either because the new Executive Director kept expanding member services at the GDA until we finally acquired our own building with room to grow and rental space to help with the payments.

The staff members helped the GDA volunteers become award winning editors, relevant ADA Council members and finally even President of the ADA. All this under the watchful eye of the Executive Director. Besides helping Georgia become one of the outstanding state dental associations in the ADA universe, she became a councilor to ADA Executive directors and the President of the association of state executive directors. She was a teacher to all and her council was sought by countless people. Her skills as

#### What is the ADA doing for you?

With another ADA House of Delegates coming up fast, your Georgia delegation was hard at work this summer trying to get things in order for this year's session. At the moment very few resolutions have surfaced from other states however Georgia has already started working on one of our own.

As some of you know that Georgia CMO's (administrators of Peach care) brag to our state legislators and our federal government about what a fabulous job they are doing in the state based on their HEDIS score (Healthcare Effectiveness Data and Information Set ). Although, we all know that the HEDIS score is a VERY poor way of rating how successful a dental program is our legislators do not understand this and therefore see the CMO's as a very successful way to implement a dental insurance program. So Georgia is currently drafting a resolution that would have the ADA lobbyist work very hard at forcing CMO's to use a different type of scoring besides HEDIS to show how poor of a job the CMO's are actually doing in our state. If we are successful in doing this the CMO's will be forced to show the reality to our legislators. They will then understand that extremely low reimbursement rates coupled with high overhead in these programs make it impossible for the dentists of Georgia to serve the needs of our most at risk patients.

Some of you may think that this does not affect them because you do not accept Peach care or other state subsidies however this could have a big impact on your practice too. Insurance companies look at the reimbursement rates set forth by Medicaid and Peach care. If they see how "successful" a program can be with rock bottom fees then the insurance companies can then lower their rates as well. This has already happened in one state where one insurance company insured a large majority of the state.

Your ADA dues money and your ADPAC dollars are very important to making our voices loud and clear in Washington. As usual our lobbyist will be keeping an eye on the "affordable care act" as it is put into action. No one is yet to understand how exactly the exchanges will work and how it will affect dentistry?
